

# SCHOLARSHIPS FOR SY 2025-2026:

## 1. CATHOLIC TUITION STUDENT ORGANIZATION (CTSO):

- CTSO scholarship applications are now open for the 2025-2026 school year and the deadline is **May 1st, 2025.**
- All Saints will receive scholarship awards at the end of June or early July. You will get a confirmation email that states you will be contacted by us but we will have no information to give you until end of June or July when Fair has reviewed your application.
- **This scholarship is for students who will be entering Kindergarten to 8th grade. I encourage you to apply!**
- Please fill out the entire application thoroughly and when you get to the part of the application that asks for your tuition need enter **\$6500.00** also fill out the last box and give a brief explanation on your need for tuition assistance. The FAIR office takes this information into account.

### **You will need the following to complete and submit your application online:**

1. **School Code: 800 & School Password: ctso800**
2. Valid email address
3. Credit card (MasterCard or visa) to complete payment processing. There is a fee.
4. **You must now upload your tax documents to FAIR.** They must be in PDF format and NOT password protected. Once you have submitted your online application, you will be brought back to the FAIR Home page. Next to the "Status" of your submitted application, you will see a link for "Upload Documents". Click on that link to select your file(s) to upload.

## 2. INSTITUTE FOR BETTER EDUCATION (IBE):

- Financial Need Based awards, Individual and Plus awards
- School age students K-8 or preschoolers with an Arizona Public School IEP or 504 plans
- Apply online [www.ibescholarship.org](http://www.ibescholarship.org)
- Last two pay stubs for all income earners to accompany the application.
- The application will not be considered complete without this documentation.
- The law requires them to consider current income and they feel pay stubs are the best way to accomplish that.
- Please check the website for more information.
- Deadline for first round of funding is **June 1, 2025** application is currently available.

### 3. **ARIZONA LEADERSHIP FOUNDATION:**

- 2025-26 Application Period will be open from April 15 – June 18, 2025.
- The Arizona Leadership Foundation offers Low-Income Corporate Income Tax Credit (CTC) Scholarship Program and the Disabled/Displaced Corporate Income Tax Credit Program.
- This scholarship combines with CTSO and IBE.
- Scholarship applications are accepted via the online portal. In addition to what is submitted supplemental forms are also required for applications. Please read the entire application and submit supporting documents.
